INVESTMENT OBJECTIVE

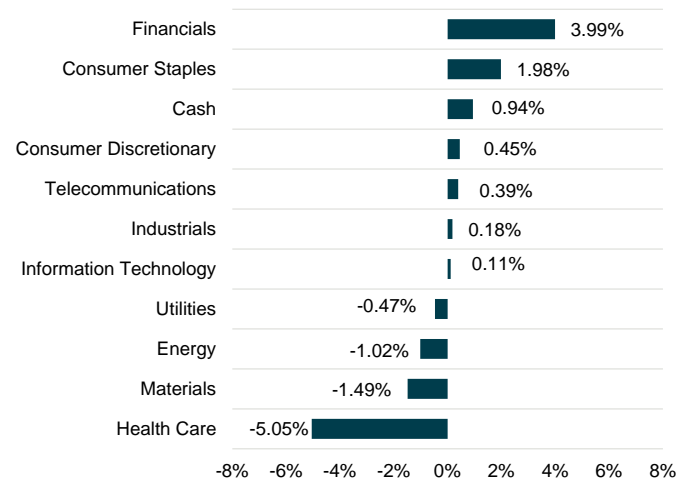
CUMULATIVE RETURN
