INVESTMENT OBJECTIVE

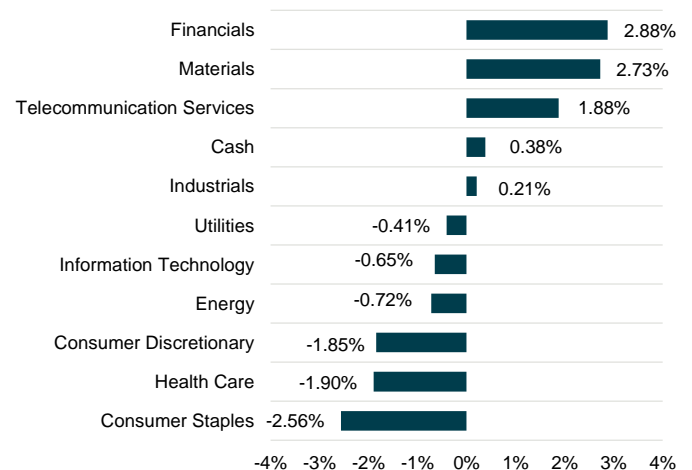

PERFORMANCE COMMENTARY

Avoidance of an untidy Greek default in the Euro zone brought some confidence back to markets during July. This renewed confidence did not extend to the Resources sectors as both Energy and Metals and Mining underperformed. While gold stocks had bucked the trend of the broader resources malaise of the past few months they were sold off aggressively during the past month. Overweight positions in Evolution, Metal-X and Independence group all detracted for the Fund. An underweight to healthcare giant CSL also detracted as the stock rallied towards \$100. Overweight positions in Echo Entertainment and Select Harvest added most along with having no holding in the large gold miner Newcrest. During July the key changes were reducing weight in Westpac and Macquarie as well as gold miners Independence and Evolution. This was matched by increasing exposure to Suncorp, Woodside, Downer and AGL.
